PARTICIPANT REQUIREMENTS

1. All participants, including every person in a group, are required to sign the following forms:
 - a. Waiver/Release for the 2023 Norco Horseweek Parade, Events and Communicable Disease including COVID-19
2. Participants may not distribute or throw merchandise or articles along the parade route, including candy, trinkets, etc. Any such activity will result in immediate disqualification.
3. All units are required to complete the route, keep moving at a safe distance, with **no gaps** or stopping to perform.
4. Participants may not play live or recorded music until they leave the Corona Avenue staging area.
5. All equestrian participants ages 17 and under are required to wear a helmet, and all equestrian participants ages 9 and under must march with an adult.
6. No vehicles, including cars, trucks, or semi-trucks, are allowed along the parade route.
7. Failure to follow the instructions of the Parade Officials and/or City of Norco Staff shall be cause for disqualification.

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate at the Horseweek Parade 2023 and/or related events and activities included but is not limited to listed events/activities:

1. I fully understand that my participation in the 2023 Horseweek Parade (hereinafter "event") which includes but is not limited to events and activities such as parade, games, vendors, activities, Volunteers, Committee Members, which exposes me to the risk of personal injury, death or property damage. I hereby acknowledge that I am voluntarily participating in this event and agree to assume any such risks.
2. I hereby release, discharge, hold harmless and agree not to sue The Horseweek Committee or City of Norco for any injury, death or damage to or loss of personal property arising out of, or in connection with, my participation in the events from whatever cause, including the active or passive negligence of The Horseweek Committee or City of Norco or any other participants in the events.
3. In consideration for being permitted to participate in the event, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless The Horseweek Committee or City of Norco from any and all claims, demands actions or suits arising out of or in connection with my participation in the events.
4. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
