# ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT WAIVER/RELEASE FOR EVENT AND COMMUNICABLE DISEASES INCLUDING COVID-19

In consideration of being allowed to participate at the City of Norco Ingalls Event Center 2025 NORCO HORSEWEEK EVENT programs/related events and activities included but not limited to listed activities.

- 1. I fully understand that my participation in the 2025 NORCO HORSEWEEK EVENT Events /Activities (hereinafter "events/ classes and community events") includes but is not limited to Opening Ceremony with Horseback Riders carrying Flags, Specialty Act, Wagon & Buggy, Extreme Ranch Rodeo (Wild Cow Milking, Branding, Sled Rawhide Race, Bronc Riding, Donkey River Rescue, Team Branding, Steer Roping, Cow Doctoring, (Ribbon on Tail), Mutton Busting) Horseback Drill Teams, Horseback Pageant Riders with flags, Lawnmower Races, Ladies Night, Challenged Children's Rodeo, Sixth Street Parade, Chili Cook Off, Beard Contest, Quarter Dip, Adult Fun Night, Junior Bull Riding, Food Trucks, Pancake Breakfast, BBQ, Poker Ride, Horseshoe Pitch, Bingo, Texas Hold' Em Tournament, 4D and Extreme Barrel Racing, Obstacle Course, Volunteers, Committee Members and Vendors and Youth Fun Day which exposes me to the risk of personal injury, death or property damage. I hereby acknowledge that I am voluntarily participating in this event/class/community activities and agree to assume any such risks.
- 2. I hereby release, discharge, hold harmless and agree not to sue the NORCO HORSEWEEK Event Committee and the City of Norco for any injury, death or damage to or loss of personal property arising out of, or in connection with, my participation in the NORCO HORSEWEEK RODEO events/classes or community activities from whatever cause, including the active or passive negligence of the NORCO HORSEWEEK Event Committee or City of Norco or any other participants in the Rodeo and Community events/classes or activities.
- 3. In consideration for being permitted to participate in any of the NORCO HORSEWEEK RODEO and Community event/ classes and activities, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless the NORCO HORSEWEEK Event Committee and the City of Norco from any and all claims, demands actions or suits arising out of or in connection with my participation in the events/classes.
- 4. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and.
- 5. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation; and,
- 6. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe and any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 7. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS The NORCO HORSEWEEK EVENT Committee and the City of Norco, George Ingalls Event Center their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
